## **IPM statement**

It is the goal of <u>ACALANES UNION HIGH SCHOOL DISTRICT</u> to implement IPM by focusing on long-term prevention or suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

# Pest identification, monitoring and inspection

Pest Identification is done by: Grounds & Maintenance Staff & EcoLabs

Monitoring and inspecting for pests and conditions that lead to pest problems are done regularly by <u>Grounds & Maintenance Staff &</u> <u>EcoLabs</u> and results are communicated to the IPM Coordinator.

Specific information about monitoring and inspecting for pests, such as locations, times, or techniques include:

STICKY BOARDS ARE PLACED IN KITCHENS AND RAT BOXES ARE PLACED OUTDOORS. THEY ARE MONITORED ON A MONTHLY BASIS OR MORE FREQUENETLY WHEN NEEDED BY ECOLAB. MECHANCIAL GOPHER AND SQUIRREL TRAPS ARE SET AND MONITORED BY THE GROUNDS STAFF.
