2016 GRAD NIGHT POLICIES & PROCEDURES - RELEASE FORM

OBJECTIVE: The intent of Grad Night is to provide a fun-filled environment for our graduating seniors that will allow them to safely celebrate one of the most exciting events of their lives.

THREE REQUIRED FROMS (No student will be admitted without the signed agreements on file.): Each participating student and the parents/guardians of each participating student shall sign an Authorization Form which includes three agreements: 1) Code of Conduct Agreement, including a Consent to Search all property and clothes which the student seeks to wear into Grad Night; 2) Medical Authorization Form; 3) Release and Waiver of Liability Form. All three agreements are found on the Authorization Form. In addition, students need to submit the Umigo Kart Racing Waiver and a Plan It Waiver.

INAPPROPRIATE BEHAVIOR: Any conduct that interferes with the enjoyment of others at Grad Night is inappropriate behavior. Such behavior includes, but is not limited to: fighting, roughhousing, taunting, defacing or destroying property or refusing to comply with the instructions of the Grad Night Committee. Any participant whom the Grad Night Committee believes to be engaging in an inappropriate behavior will be first asked to stop, and if the behavior persists or is repeated, the participant will be asked to leave. The participant's parent/guardian or the designated alternate adult on the permission slip will be called to pick up the student.

PERSONAL PROPERTY: Students are responsible for any personal property taken to the venue. We suggest that only a cell phone and closed toe shoes (needed if your child wears non-closed toe shoes, such as flip-flops, to the event) come with your student. **Please leave any valuables at home.**

ADMISSION AND DEPARTURES:

- At 5pm on Friday, June 10, 2016 prior to graduation, students check in to Grad Night in front of the cafeteria. After check in, students proceed to graduation. After graduation, students assemble at the front of the cafeteria for a light snack and bus transportation. The departure process begins at 7:45 pm and continues until 8:15 pm. Buses depart for Umigo, located in Livermore, at 8:30pm.
- If your child signed up for Grad Night and does not check in, an attempt will be made to notify parents (phone and text). Each participating student and the parents/guardians of each participating student agree that once checked in, the student shall remain at Grad Night until the conclusion at approximately 4:00 AM on Saturday, June 11, 2016. In case of illness, the student will only be released to a parent or guardian.
- Buses plan to leave Umigo at 3:00am on Saturday, June 11 and should arrive at Acalanes by approximately 3:45 am.

ALCOHOL, TOBACCO, WEAPONS, VAPE PENS, AND DRUGS - ZERO TOLERANCE POLICY:

- The use and/or possession of alcohol, drugs, or weapons, shall not be allowed at Grad Night. This policy applies to all students as well as to all other participants, parent volunteers, vendors and contractors. Any alcohol, drugs, or weapons found on any student or in their clothing will be confiscated and turned over to the Lafayette Police.
- Any person observed to be using alcohol, tobacco, or drugs, or believed to have been using alcohol or drugs at Grad Night will be asked to leave Grad Night.
- Any participant asked to leave Grad Night will be required to remain at Umigo in Livermore until a parent, guardian or the person designated in the Medical Emergency Authorization, can pick up the student. They will not be allowed to return.
