Safe School Notification CODE OF CONDUCT

The following are for first offenses. Please see the student handbook for second or third offenses.

DANGEROUS OBJECTS (KNIVES, FIREARMS, EXPLOSIVES)

Possession, sale, or furnishing of any knife, explosive, or other dangerous object, including but not limited to Swiss-army style knives, exacto knives, box cutters, single-edged razor blades, pepper spray, and imitation firearms.

- First Offense: Suspension, Police contact, Possible expulsion (could be mandatory expulsion)

Possession, sale or furnishing any firearm:

- First Offense: Expulsion for 12 calendar months

OTHER PROHIBITED ITEMS:

Laser pointer, tobacco or nicotine products, including but not limited to cigarettes; snuff, smokeless tobacco, chew products, and betel; prescription and non-prescription drugs; aerosol cans and drug paraphernalia.

- First Offense: Suspension, Police contact

SEXUAL HARASSMENT:

Sexual harassment is a violation of state and federal laws and disciplinary consequences will be applied.

- First Offense: Parent conference, Detention, Saturday School, Suspension, Expulsion

SEXUAL BATTERY/ASSAULT/HAZING:

Sexual battery, which involves unlawful and unwanted touching of another or sexual assault, is a violation of the penal code and may result in a recommendation for expulsion

- First Offense: Suspension, Police contact, Expulsion

CONTROLLED SUBSTANCE (ILLEGAL DRUGS, ALCOHOL, INTOXICANTS):

Using or possessing a controlled substance or being under the influence:

- First Offense: Suspension, Police contact, Expulsion, Alternative Placement

Selling or furnishing a controlled substance:

- First Offense: Recommendation for Expulsion

FIGHTING/THREATS/BULLYING/RACIAL SLURS/HATE VIOLENCE:

Fighting, attempting to fight, threats to fight, threats, bullying, racial slurs, or acts of hate violence will result in disciplinary actions:

- First Offense: Parent conference, Suspension, Police contact, Expulsion, Alternative Placement

SERIOUS BODILY INJURY/TERRORIST THREAT/EXTORTION/ROBBERY:

For causing serious bodily injury, striking, or threatening a district employee or making terrorist threats.

- First Offense: Suspension, Police contact, Expulsion

ARSON/DESTRUCTION OF PROPERTY:

- First Offense: Parent conference, Exclusion from school activities, Suspension, Police contact, Expulsion

THESE REGULATIONS APPLY AT ANY SCHOOL RELATED ACTIVITY INCLUDING, BUT NOT LIMITED TO:

On school grounds, going to and from school, including the bus stop, at, going to, or coming from a school-sponsored activity.
