Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

To use non-chemical means to control pests whenever possible, and to use the least toxic, effective chemicals when needed.

Sticky boards are placed in kitchens and rat boxes are placed outdoors. They are monitored on a monthly basis and as needed by EcoLabs. Mechanical gopher traps are set by and monitored by Grounds staff.
