Acalanes Union High School District (AUHSD) is seeking 3 Gbps to 10 Gbps Leased Lit Fiber Transport services, connecting all schools and non-instructional facilities within District. This Form 470 is seeking month-to-month pricing for lit fiber services for District when current lit fiber contract ends on 6/30/2022, if new lit fiber contracted services are not operational by July 1, 2022:

1) four (4) 3 Gbps connections connecting to District collector site, 1963 Tice Valley Road, Walnut Creek, CA; and

2) one (1) 10 Gbps high-speed service for transport from collector site at 1963 Tice Valley Road, Walnut Creek, CA, to Internet Service Provider (ISP).

The requested service is for connections from the four District high schools as listed below, to/from the Collector site:
