Call the Meeting to Order	Mr. Duckworth called the meeting to order at 7:02 PM.

Public Comments	No public comments were made.
<u>District Updates</u>	<i>Mr.</i> Nickerson reviewed the 2017-2018 school calendar with the Committee and explained how the 7 th period fit into the modified block schedule. Actual hours were shortened a bit for the week but students benefited from the consistent, longer classroom hours. He also reported to the Committee the popularity of the new Academy time and online scheduling for tutoring. Scheduling time in the middle of the school day rather than after school seem to encourage more student participation. The pros and cons of an 8:30 AM start time was discussed; expect the concept to ramp up in the future. Overall, the new modified schedule is a success.
	<i>Mr. Nickerson also shared new school year calendar start times with the Committee. Several new concepts are being considered such as a mid-August. He is working with the K-8 feeder districts and will report back to the Committee at the next meeting.</i>

<u>Measures G&A</u> <u>Budget</u> Ms. Bautista continued to present the Measures G & A budget to the Committee and reviewed the 2016-2017 unaudited actuals, pointing out that total revenue was \$144,000 less than 2015-2016 due to an increase in senior exemptions. She reviewed personnel changes that occurred throughout the year that brought staffing more in line with the measures.
